*** Impact Investing**

Investing capital with the intention to generate both financial returns, and measurable, positive, environmental or social results. Unlike traditional investing which focuses only on profit, or philanthropy, which gives money for immediate aid, Impact Investing channels capital to solve real problems and generate profit at the same time
